Dear Members of the Curriculum Committee:

By way of background for our proposal to restore/add a minor in Criminal Justice:

For many years, the Program supported a Criminal Justice Studies minor. Beginning in the 1990s, instructional support for criminal justice-related classes increasingly failed to meet the demand for those classes. Seats in required classes were prioritized for majors and there was rarely, if ever, a seat available for a non-major, including minors.

At the same time, the budget constraints faced by the University meant that there would not be any long-term solution to the problem. As a result, the Program leadership and faculty decided to eliminate the minor.

Over the past four years, the number of tenure track and nontenure track lines for contributing departments has gradually increased to the point where we now regularly have sufficient seats in criminal justice affiliated classes to be able to support a minor. We regularly have inquiries about pursuing a minor in criminal justice. These student-initiated inquires come from a wide range of majors, but they are predominately those in the social sciences. When developing this proposal, we also considered those students who are interested in studying criminal justice but are unable to meet the admission requirements to become a criminal justice major and/or those students who are unable to fulfill the academic requirements for a criminal justice major.

The proposal has the support of CJ-affiliated faculty and the Program's Executive Committee. Department heads in political science (Scott Ainsworth) and sociology (Jody Clay-Warner) do not foresee any issues with the offering of courses included in this proposal. The interim dean of SPIA, Bob Grafstein, is also on board with the proposal.
