State the reasons for deactivating or terminating the program.

USG rules prescribe that the program cannot continue unless there are at least five graduates a year. This has historically not been the case; the average for the past five years is 2.8. We do not see this changing much in the years ahead.

State the plans for allowing those students already in a program to complete degree requirements, including specific information on a.) how students will be notified of the program termination and b.) how students will be counseled on completing the program.

- a. We will notify the students currently in the program of this change through advisement, a mailed letter, and email, stating that the program is being terminated after their graduation.
- b. There are no issues or concerns with current students completing the program. All coursework required for this degree is also required for other graduate degrees in music education we currently own, including the Doctor of Education in Music Education and the Doctor of Philosophy. No graduate coursework in music education will be eliminated or altered, and all opportunities for these students to finish their degree will remain, even after the program is closed. The only long-term effect of this change is that the Hugh Hodgson School of Music will have fewer graduate students in our graduate programs overall. Resource commitments and course offerings are unchanged.

What will be done to minimize the impact or termination of the program upon the personal and professional lives of the faculty and staff involved, specifically a.) how will faculty and staff be notified of the termination and b.) how will faculty and staff be re-deployed?

There will be minimal impact on the personal and professional lives of the faculty and staff involved in the degree. As noted above, all coursework and other matters involved with this degree remain, as they are needed for other programs. There will be no members of the faculty and staff re-deployed.

What will be done to insure that deactivation or termination of the program does not weaken other programs (graduate, undergraduate, or professional) for which the department may be responsible?

There will certainly be some slight effect on our graduate programs from reduced numbers, but other programs are sufficiently healthy to maintain appropriate course enrollments and a cohort of graduate students in graduate music education programs.

What plans, if any, is there for subsequent reactivation or reinstatement, respectively, of the deactivated or terminated program?

We have no current plans to reactivate or reinstate this program.

Commentary

We understand, after speaking with the UGA Office of Curriculum Systems, that most EdS majors, specifically those managed within the College of Education, will be saved by combining them as emphases within one larger EdS major. We do not have that option, as we are in a different college, and there is little our EdS degree has in common with the EdS in Art; these could not be combined in a similar manner, and in any event would not bring the graduating average to five a year.

Cutting the EdS in Music Education brings no savings in personnel, resources, or effort—we just cut students. UGA is currently the only university in Georgia that offers this degree.
