Approval of the Minutes

Committee on Academic Standards: Joe Hermanowicz reported that four cases were considered by the committee in the previous month, all regarding petitions from undergraduates for course substitutions and/or transfer credit to satisfy requirements. All four petitions were approved.

## New Business

## 1) Graduate Faculty Discussion

Bram Tucker explained that the Anthropology department has two concerns about the Graduate Faculty Status situation. First, the department wonders whether the burden of application and re-application for Graduate Faculty Status is a worthwhile use of administrative resources. Second, the department is having difficulty filling graduate student committees because of a lack of graduate faculty and confusing rules about who can and who cannot serve on committees. Tucker noted that retired faculty can sit on committees, but must apply for adjunct status before retiring in order to retain Graduate Faculty Status.

Discussion ensued. Charles Doyle asked whether other universities have similar systems. Michael Hahn noted that a faculty member at the University of Oregon was surprised to learn of UGA's policy in this regard, considering it a "burdensome anachronism." Tucker noted that in a recent survey of Franklin College units, many faculty expressed an interest in retaining the system, although most faculty agree that the system should operate with less paperwork. Various suggestions from the members of the Senate were made regarding elimination of all or part of the Graduate Faculty Status system. Tucker will prepare a motion for the Senate to consider at its January meeting. In the meantime, Dean Stokes will post the results of the recent survey on this issue to the website. 2) Proposal for Changing the Artificial Intelligence Center to the Institute for Artificial Intelligence

Don Potter presented a proposal to change the Artificial Intelligence Center to the Institute for Artificial Intelligence, noting that the unit does not meet the criteria for a Center within the Franklin College because it offers a degree program.

Hahn motioned to approve the proposed change, and Short seconded. The motion passed unanimously on a voice vote.
3) Termination of MAT degrees in French and Spanish Offered by Romance Languages Dept.

Associate Dean Hugh Ruppersburg explained that there are no students seeking MAT degrees in French or Spanish in Romance Languages, so the Committee on Curriculum recommended termination. A brief discussion ensued, after which the committee's recommendation was approved unanimously on a voice vote.
